- 2. On Verification with the BCA, Mr. Manish Raj, CEO of Bihar has brought to the Notice of this Office that BCA has never appointed Mr. Paras Nath Rai as the Ethics Officer & Ombudsman. On verification of the requisite documents submitted by Mr. Manish Raj it is found that BCA has appointed Mr. Raghvendra Kumar as the Ethics Officer and Ombudsman for the period of January' 2020 to February' 2023 and thereafter Mr. Nawal Kishore Singh from 01.03.2023 to till date.
- 3. On Verification it is also found that there is no valid Documentary proof in support of the contention of Mr. Amit Kumar with regards to Debarring of Members of Committee Management or BCA losing its Quorum.
- 4. On further verification of the Documents it is found that Mr. Amit Kumar no longer holds the position of 'Hon. Secretary' of BCA and the same is confirmed vide order dated 30.05.2023 passed by Mr. Naval Kishore Singh in BCA/Ombudsman/02 of 2023 by the Ethics Officer & Ombudsman.
- 5. It is also brought to Notice that an FIR dated 26.05.2023 Registered at Patiliputra as P. S. Case No. 421 of 2023 has been filed against Mr. Amit Kumar wherein it is alleged that Mr. Amit Kumar has committed offence under section 419, 420,

- Court of Tripura numbered as W.P(C) 471 of 2023 wherein an Order dated 03.08.2023 was passed settling the disputes between the Office Bearers on a condition that both the Decisions of the Apex Council as well as General Body would be inoperative and position of all the Office Bearers are Restored.
- 3. On Verification, it is found that on 09.08.2023 the Decision was taken in the Special General meeting declaring Mr. Tapash Ghosh as indisposed to hold the post of Secretary of TCA. Being aggrieved and dissatisfied with the same Mr. Tapash Ghosh had filed Writ Petition before the Hon'ble High Court of Tripura numbered as W.P(C) 532 of 2023 challenging the Order dated 11.08.2023 passed by President which is pending till date.
- 4. On Verification it is found that W.P(C) 471 of 2023 and W.P(C) 532 of 2023 filed by Mr. Tapash Ghosh in the High Court of Tripura are pending till date and therefore it is not in the interest of Justice to consider the Objection filed by Mr. Tapash Ghosh.
- Further, the Nomination Application held on behalf of TCA nominating Mr. Tapan Lodh is found to be complete in all aspects.
- Taking into account the facts stated above, the Objections stand rejected.
