**SUB: NOTICE OF ELECTION SCHEDULE AND CALL FOR FULL  
MEMBERS**

**TO FILE APPLICATIONS TO NOMINATE THEIR RESPECTIVE  
REPRESENTATIVES**

1. The Electoral Officer, Board of Control for Cricket in India (“**BCCI**”) hereby invites Full Members of the BCCI to submit Applications to have their respective Representatives (“**Representatives**”) included in the Electoral Roll for the BCCI General Elections - 2025 to be held at the Annual General Meeting of the BCCI, on **28 September 2025**, for the Posts specified below (“**BCCI General Elections’ 2025**”):
  - A. Five (05) Office Bearer’s Post under Rule 06 of the BCCI Constitution:
    1. The President
    2. The Vice-President
    3. The Secretary
    4. The Joint Secretary
    5. The Treasurer
  - B. One (01) Elective Post of Member of the Apex Council under Rule 14 of the BCCI Constitution.
  - C. Two (02) Elective Posts of Members of the Governing Council under Rule 28 of the BCCI Constitution.
2. The BCCI Election process shall be conducted in accordance with the Schedule provided in Table 1 below (“**Election Schedule**”).

3. In order for a Representative to be considered for inclusion in the Electoral Roll for the BCCI General Elections - 2025, each Full Member and its Representative shall be required to submit an application containing all the Documents/Material specified below within the timeline(s) specified for receipt of such Applications in the Election Schedule above.

- A. A Representative Nomination Form in the prescribed **Form A** (enclosed herewith at **Annexure I**) duly completed and stamped by the Full Member and attested by a Notary/Oath Commissioner.
- B. A Declaration-cum Affidavit by the Representative in the prescribed **Form B** (enclosed herewith at **Annexure I**) duly signed by the Representative and attested by a Notary/Oath Commissioner.
- C. Self-Attested copy of Identification and Age Proof of Representative - Aadhar Card, Voter ID Card or Passport. **(Any one)**
- D. Self-Attested copy of Address Proof of Representative - Aadhar Card, Voter ID Card, Passport or Driving License. **(Any one)**
- E. Self-Attested copy of PAN Card of Representative.
- F. An extract of the Relevant Provision in the Full Member's Constitution specifying the manner in which the Representative is to be nominated/appointed by the Full Member (either by the General Body or Apex Council or equivalent Body).

G. A copy of the Resolution passed by the appropriate Nomination/Appointing Authority of the Representative, as per the Full Member's Constitution.

**H. An Information Sheet from the Representative specifying all Elective Posts held by the Representative in the BCCI and/or any Full Member of the BCCI Previously and/or Currently, along with the Name of the Elective Posts and Tenures of such positions. The Information in this regard is to be submitted in the prescribed Form C (enclosed herewith at Annexure I) signed by the Representative and Duly attested by a Notary/Oath Commissioner.**

4. Scanned copies of all Documentation prescribed in Paragraph 3 above are required to be sent via email, to [electoral.officer@bcci.tv](mailto:electoral.officer@bcci.tv) before 8:00 PM on 12<sup>th</sup> September 2025.
5. Originals of all Application Documents are required to be sent in a Sealed Envelope to the Address specified below and are required to reach such Address before 6:00 PM on 15<sup>th</sup> September 2025.

6. Full Members are advised to adhere to **timelines specified in Paragraph 2 and Paragraph 3** above for submission of the Applications by Full Members to the Electoral Officer, BCCI.
7. Full Members are advised to take the necessary care and conduct due diligence, while nominating their Representatives to participate in the BCCI General Elections - 2025, as per the BCCI Constitution and the Instructions/Directions/Notifications issued by the BCCI in this regard.
8. A Representative will be deemed to be eligible to participate in the BCCI General Elections - 2025 on behalf of His/ Her Full Member only if the Application filed by the Full Member and Representative meets all the requirements specified, and includes all the Documentation prescribed, in **Paragraph 3** above and the Electoral Officer, BCCI is satisfied that such Person is not Disqualified under the Applicable Rules.

9. Pursuant to the publication of Draft Electoral Roll on 13 September 2025, if anyone wants to file an Objection he/she may file it **via email to [electoral.officer@bcci.tv](mailto:electoral.officer@bcci.tv)**, in accordance with timeline specified in **Paragraph 2** above.

It is clarified that the Person filing the Objection shall be a Member of the concerned State Cricket Association affiliated to the BCCI.

10. The Electoral Officer reserves the Right to require further Information or seek clarification on and in respect of any matter relating to the BCCI General Elections - 2025.

11. In case of any Disputes or Objections arising with respect to the BCCI General Elections - 2025, from the Declaration or Publication of Electoral Roll of qualified Members to the Declaration of Results including but not limited to objection to candidacy, disqualification, eligibility to vote or the admission or rejection of a vote, the Electoral Officer, BCCI shall decide the same and such a decision shall be Final and Conclusive.

- h) The Representative is not required to undergo a **Cooling Off period of 3 YEARS in accordance with the BCCI Rules and Regulations;**
- i) The Representative has not been an Office Bearer of the BCCI for a **Cumulative period of 9 YEARS;**
- j) In support of paragraphs h) and i) above, an Information Sheet is enclosed herewith in the **Annexure I Form C** specifying all Elective Posts held by the Representative in the BCCI and/or in the Full Member Previously and/or Currently, along with the Name of the Posts and Tenures of such positions;
- k) In support of the Full Member's Application to have the Representative serve as the official representative of the Full Member for the BCCI General Elections - 2025 to be held on **28 September 2025** attached herewith are the following additional documents:
