1. Pursuant to the notice issued to Ms. Shantha Rangaswamy, Reply to the Complaint had been received from the Board of Control for Cricket in India (for short "the BCCI"). - 4. Accordingly, I have heard Mr. Sanjeev Gupta and the Representatives of the BCCI.
- 5. Mr. Gupta, the Complainant, submits that the Complaint may be decided in the light of the statement made by Ms. Rangaswamy in her Reply dated 24th December 2019 and the Reply filed by the BCCI on her behalf on 10th October 2019, wherein it is stated that Ms. Rangaswamy had resigned as member of the Ad Hoc CAC and also as Director of Indian Cricket Association on 29th September 2019.
- 6. Having examined the Complaint in light of the aforestated facts, the Ethics Officer is of the opinion that the present Complaint is rendered infructuous. It is disposed of accordingly.
- 7. A copy of this Order be supplied to all concerned.
