In response to your email dated 02-08-2017 addressed to the undersigned by you , it is apt to state here that as per the constitution of JKCA, it has three types of meetings namely : (1) Working Committee Meetings (2) General Council Meetings and (3) Extra-ordinary General Council Meetings . The working committee is empowered with administration and management of the Association consisting of 2 members of each affiliated clubs amounting total 32 clubs in number including 7 Govt. institutions which comes to total number of members equaling to 64 members and those are eligible to elect the office bearers of JKCA. The General Council and the Extra Ordinary General Council consists of 5 members from each affiliated clubs including above stated 2 members of the working committee amounting to total number of members to 160. The main function of General Council meeting is to pass the accounts while as the main function of Extra-ordinary General Council is amendment of the constitution. Therefore, the list of the

It is apt to state here that some of the clubs namely Shastri Cricket Club Jammu, Rehari Cricket Club Jammu, International Cricket Club Jammu, Friends Cricket Club Jammu and Modern Cricket Club Jammu have some interse disputes and the same was informed to the house in its working committee meeting held on 18-09-2016. During the course of the said meeting after threadbare discussion on the issues regarding the controversies among the above said clubs, it was unanimously decided that as the Hon'ble Supreme Court by its Order dated 18-07-2016 have passed various directions including the appointment of Ombudsman who shall settle such disputes, therefore, the association should also follow the said directions in order to set the house in order, as such the undersigned being the General Secretary of JKCA was given authority by the house unanimously to take steps in this regard immediately. Accordingly, the undersigned has taken necessary steps and an ombudsman namely Iqbal Ahmad Ansari retired chief Justice, Patna High Court came to be appointed for the purpose of settlement of disputes duly informed to you as well vide communication JKCA/GS/ 1239-1241 dated 16-06-2017 which stands acknowledged by you as well through E-mail dated 27<sup>th</sup> June 2017 and in this regard it is worthwhile to make mention that he has since assumed office on 10-07-2017 and has started adjudication of the matters in dispute. Besides one of the clubs namely Amateur Cricket Club, Srinagar (ACC, Srinagar) the Secretary of the club (who was Ex-Treasurer/General Secretary of the JKCA) who is allegedly involved in the infamous multi-crore scam of misappropriation of funds that has hit JKCA, as such, its voting rights are put under suspension by the working committee of JKCA in its meeting held on 03-10-2015.

So far as the names of General Council / Extra-ordinary General Council members are concerned, as the association has not so far called for any such meetings, however, as sought by
