**SUB: NOTICE OF ELECTION SCHEDULE AND CALL FOR FULL MEMBERS TO
FILE APPLICATIONS TO NOMINATE THEIR RESPECTIVE
REPRESENTATIVES**

1. The Electoral Officer, Board of Control for Cricket in India (“BCCI”) hereby invites Full Members of the BCCI to submit applications to have their respective representatives (“**Representatives**”) included in the electoral roll for the election to be held at the General Meeting of the BCCI, on 23 October 2019, for the posts specified below (“**BCCI Election**”):
 - (i) Office Bearers of the BCCI;
 - (ii) One (1) member of the Apex Council (as a representative of BCCI Members under Rule 14 of the BCCI Constitution); and
 - (iii) Two (2) members of the Governing Council (as members elected by the General Body under Rule 28(2)(i) of the BCCI Constitution).

2. The BCCI Election process shall be conducted in accordance with the Schedule provided in Table 1 below (“**Election Schedule**”) and accordingly, Rules 2 and 3 of the Rules of Procedure for the BCCI Election Rules of Procedure, as issued by the Electoral Officer, BCCI on 16 August 2019, shall stand amended to the extent necessary to give effect to the Election Schedule. *Applications and nominations received only from those member associations or representatives of members, who have been determined to be compliant by the Supreme Court appointed Committee of Administrators for BCCI, in accordance with the Hon’ble Supreme Court judgment dated 9 August 2018 read with the Supreme Court order dated 20 September 2019, shall be entertained by the Electoral Officer.*

3. In order for a Representative to be considered for inclusion in the electoral roll for the BCCI Election, each Full Member and its Representative shall be required to submit an application

containing all the documents/material specified below within the deadline(s) specified for receipt of such applications in the Election Schedule.

- a) A Representative Nomination Form in the prescribed **Form A** (enclosed herewith in Annexure 1) duly completed and stamped by the Full Member and attested by a notary/oath commissioner.
- b) A Declaration-cum Affidavit by the Representative in the prescribed **Form A.1** (enclosed herewith in Annexure 2) duly signed by the Representative and attested by a notary/oath commissioner.
- c) Self-attested copy of Identification and Age Proof of Representative– Passport Voter ID Card or Aadhar Card.
- d) Self-attested copy of Address Proof of Representative – Voter Card, Passport, Driving License.
- e) Self-attested copy of PAN Card of Representative.
- f) An extract of the relevant provision in the Full Member’s constitution specifying the manner in which the Representative is to be nominated/appointed by the Full Member (either by the general body or Apex Council or equivalent body).
- g) A copy of the resolution passed by the appropriate nomination/appointing authority of the Representative, as per the Full Member’s constitution.
- h) If the Representative is employed by a Government/Public Sector undertaking under ‘Sports Quota’, a certificate from such Government/Public Sector employer stating that the Representative is employed under ‘Sports Quota’.
- i) An information sheet from the Representative specifying all Office Bearer positions held by the Representative in the BCCI or any Member of the BCCI previously, along with the terms and tenures of such positions.

Scanned copies of all documentation prescribed in Paragraph 3 are required to be sent via email, to electoral.officer@bcci.tv before 3:00 PM on 4 October 2019. Originals of all application documents are required to be sent in a sealed envelope to the address specified below and are required to reach such address before 3:00 PM on 7 October 2019.

4. Any applications that are submitted by Full Members after the deadlines specified in Paragraph 2 and Paragraph 3 above shall not be considered by the Electoral Officer, BCCI and the Representative to whom such application relates shall not be entitled to participate in the BCCI Election.
5. Full Members are advised to take the necessary care, and conduct necessary due diligence, while nominating their Representatives to participate in the BCCI Election, as per their constitutional documents, the BCCI Constitution and the instructions/directions/notifications issued by the Committee of Administrators, BCCI, in this regard.
6. A Representative will be deemed to be eligible to participate in the BCCI Election on behalf of his/her Full Member only if the application filed by the Full Member and Representative meets all the requirements specified, and includes all the documentation prescribed, in Paragraph 3 above and the Electoral Officer, BCCI is satisfied that such person is not disqualified under the applicable rules.
7. Please be aware that in the event that the Electoral Officer, BCCI deems a proposed Representative to be ineligible to participate in the BCCI Election, it will not be possible for the Full Member to nominate a replacement. Therefore, it is essential that all formalities are duly complied with by the Full Member and the proposed Representative in the first instance.
8. The Electoral Officer reserves the right to require further information or seek clarification on and in respect of any matter relating to the BCCI Election.
9. In case of any disputes or objection arising with respect to the BCCI Election, from the declaration or publication of electoral roll of qualified members to the declaration of results including but not limited to objection to candidacy, disqualification, eligibility to vote or the admission or rejection of a vote, the Electoral Officer, BCCI shall decide the same and such a decision shall be final and conclusive.

- d) The Representative has not attained the age of seventy (70) years;
- e) The Representative has not been declared to be insolvent or of unsound mind;

- f) The Representative is not a Minister, or a Government Servant and does not hold a public office.

Note: It is clarified that a former player employed by the Government or a Public Sector undertaking under 'Sports Quota' will not be treated as being disqualified for being a "Government Servant" or a person holding a "public office". If such a Representative is employed by a Government/Public Sector undertaking under 'Sports Quota', kindly attach a certificate from such Government/Public Sector employer stating that the Representative is employed with such entity under the 'Sports Quota';

- g) The Representative does not hold any office or post in a sports or athletic association or federation apart from cricket;
- h) The Representative has not been charged by a Court of Law for having committed any criminal offence, i.e., no court of law has passed any order framing charges against me;
- i) The Representative has not been an Office Bearer of the BCCI for a cumulative period of 9 years;
- j) The Representative is not required to undergo a cooling off period of 3 years in accordance with the BCCI Rules and Regulations;
- k) In support of paragraphs j) and k) above, attached herewith is an information sheet specifying all Office Bearer posts held by the Representative in the BCCI or in the Full Member or any other Member of the BCCI previously, along with the terms and tenures of such positions;
- l) In support of the Full Member's application to have the Representative serve as the official representative of the Full Member for the BCCI Election to be held on 23 October 2019 attached herewith are the following additional documents:
1. A self-attested copy of the following Identification and Age Proof document of the Representative (any one): Passport Voter ID Aadhaar Card
 2. A self-attested copy of the following Address Proof document of the Representative (any one):
