

INDIAN CRICKETERS' ASSOCIATION (ICA) ELECTION - 11 OCTOBER 2019 TO 13 OCTOBER 2019

POSTS FOR WHICH ELECTIONS SHALL BE CONDUCTED

Pursuant to Section III of the Election Notification for ICA Election issued on 30 September 2019 ("ICA Election Notification"), the Electoral Officer, BCCI hereby announces that elections are proposed to be conducted for the posts specified below during the ICA Election to be held on 11 October 2019 to 13 October 2019:

Capitalized terms used herein but not defined shall have the meaning ascribed to them in the ICA Election Notification.

I. ICA Board

- 1. President
- 2. Secretary
- 3. Treasurer
- 4. Two (2) ICA Member Representatives*

* Article 8 (c) of the Article sprovides that at least one (1) Board member shall be a woman. In order to facilitate this requirement, it is hereby clarified that in the event that a female candidate is not elected as a President, Secretary or Treasurer on the ICA Board, the female candidate who receives the highest number of votes for the Post of Member Representative (among female candidates only) shall be elected as a Member Representative, whether or not there is more than one (1) male candidate who receives higher votes than such female candidate.

Eligbility criteria: a) If candidate is male, played at least 5 International Test Matches and/or at least 25 First Class Matches; or b) if candidate is female, played at least 10 First Class Matches.

II. ICA Representative Nominees to BCCI

- 1. One (1) Male ICA Representative Nominee to BCCI Apex Council
- 2. One (1) Female ICA Representative Nominee to BCCI Apex Council
- 3. One (1) ICA Representative Nominee to IPL Governing Council

Eligbility criteria: a) If candidate is male, played at least 5 International Test Matches and/or at least 25 First Class Matches; or b) if candidate is female, played at least 10 First Class Matches. The candidate should also not be "disqualified" to be a Councillor of the BCCI or a member of the IPL Governing Council under the BCCI Rules and Regulations, respectively.

Eligbility criteria: Candidate must be on the Final Electoral Roll from the ICA Chapter corelating to the BCCI Member Association in respect of which he/she wishes to stand for election as Representative.

**It is clarified that:

- a) Only ICA Chapters with at least ten (10) eligible male voters on the Final Electoral Roll shall elect male representative nominees to the Apex Bodies of their corresponding BCCI Member Associations in the 2019 ICA Election; and
- b) Only ICA Chapters with at least five (5) eligible female voters on the Final Electoral Roll shall elect female representative nominees to the Apex Bodies of their corresponding BCCI Member Associations in the 2019 ICA Election.

ICA Chapters that do not have at least ten (10) eligible male voters on the Electoral Roll, and/or five (5) eligible female voters on the Electoral Roll members, shall not have an election to elect their male and/or female representative nominees (as the case may be) to the corresponding BCCI Member Association(s). In such cases, the representative nominees shall be nominated by the duly elected ICA Board after the completion of the 2019 ICA Election.
